NOW, THEREFORE BE IT RESOLVED THAT the City of Brown City hereby authorizes and approves the DNR 2010 Recreation Grant Application and the necessary thirty percent (30%) matching funds (\$15,000 - \$3,800 from the Park General Fund, \$1,200 from the Fire Authority, \$10,000 Brown City Rotary Club) to accomplish the following specific improvements:
