**A RESOLUTION FORMALLY CAUSING TO BE LEVIED A SPECIAL TAX OR ASSESSMENT TO RECOVER MONIES OWED THE CITY OF BROWN CITY.**

**WHEREAS**, City Ordinance 32.19 provides the means to collect monies due to the City and to “spread such amounts against the real property chargeable therewith on the next tax roll for the collection of general city taxes;” and,

**WHEREAS**, City Ordinance 52.09 (D) requires that rates and charges due for water and sewer that remain unpaid shall be transferred to the tax roll following a notice to all owners of property within the city; and,

**WHEREAS**, there was published a City Public Notice stating “The City of Brown City will be enforcing without further Notice the City Ordinance and Fee Resolution relating to the mowing and care of lawns and lots.”; and,

**NOW THEREFORE, THE CITY OF BROWN CITY RESOLVES THAT** notice having been published in a newspaper published in the city, that the following properties will have added to their 2011 Property Tax Bill these amounts for the reason indicated:
