## **ATTORNEY'S REPORT:**

1. Attorney's Contract:

Move by CM Lukacs, second by CM Jacobson, to renew the contract with Gerard Garno as the City Attorney from the law firm of Rickard, Denney and Associates for another year at the same rate as last year. Motion Carried.

- 2. Sewer Policy: Need to set up some type of Sewer Policy for Residents that live out side of the City Limits that want to hook up to the City's Sewer System, that treats everyone the same. Also stated in this Sewer Policy that the Resident will need to annex into the City. Need to check out why Kelly Mason was denied sewer hookup and look at what was done in the past. City Attorney Garno will wait to hear from the Water and Sewer Committee. (Corrected 6/7/04 take out this and change to "previous Sewer Policy".)
- 3. VanDamme's Corn: Keith Muxlow agreed to pay for only the corn on the land that the City purchased. City Attorney approved the paying of the corn. (Corrected 6/7/04 Change to read the City paying of the corn on the east side.)
- 4. Mapleview Estates vs City of Brown City, Executive Session:

  To consult with the attorney about trial or settlement strategy in pending litigation, since an open meeting would have detrimental financial effect on the City's position.

Council came out of Executive Session at 8:25 P.M.

No action was taken in Executive Session.

Move by CM Lukacs, second by CM Nielsen, to direct City Attorney Garno to collect back connection and tap in fees from Mapleview Estates. Motion Carried.

5. Ebay: City Attorney Garno suggested that the City wait on selling the police car on Ebay until the next meeting, so he can check the legality and to gather more information.

## **CITY MANAGER'S REPORT:**

- 1. Arsenic Project: The Arsenic Removal Plant Officially went online Tuesday, May 11, 2004. On June 22 and 24 there will be an open house at the Arsenic Removal Plant. The open house will be sponsored by Severn Trent, Hamlet Environmental and Boss Engineering. They have contacted Ray Dupie to roast a couple of hogs and supply all the fixings. It is our plan to invite the Governor, US Senators, US Congressmen and other local politicians. A program will be planed and invitations will be sent out.
- 2. Blight: The City will start to crack down on blight. A notice will be on channel six and in the paper.
- 3. John Lehotan, C.P.A.: With GASB 34 lurking in the near future and my desire not to acquaint myself with GASB 34, I have enlisted the services of Lehn King, C.P.A. and his son Ryan for the March 31, 2004 audit. In an effort to ensure a smooth transition into GASB 34, Lehn will assume responsibility for

the March 31, 2004 Audit and coordinate the items needed for the March 31, 2005 GASB 34 Audit. My contract provides for the transfer of my audit responsibilities to Lehn King. City Attorney Garno wanted to look at John Lehotan contract that he has with the City.

CM Lukacs stated that the manhole cover at the corner of Buby and Kohler Road needs to be looked at.

#### TREASURER'S REPORT:

The City Council read the Treasurer Report.

Move by CM Lukacs, second by CM Navock, to direct City Treasurer Carol Walter to publish the Deferment Notice for the Summer Taxes for 2004, with the other Treasurers in the County to be put in the Sanilac County News at a cost of \$11.50. Motion Carried. (Corrected 6/7/04 – Remove comma between 2004 and with – change Walter to Walters – add comma after "Treasurers" and before "in".)

## **MAYOR'S REPORT:**

Set date for hydrant flushing for the first week of June.

Move by CM Miller, second by CM Nielsen, to set the flushing of the fire hydrants the first week of June, during the day. Motion Carried.

- 5. Fire Department will need two dump truck to hold the line for the water ball fight.
- 6. The asphalt will be put on the side of the Fire Department and the ditch in back of the Fire Hall needs to be filled in. The prep work for this project needs to be done this month for the July insulation of the asphalt.
- 7. A meeting needs to be set up with the Police, DPW and the Festival Committee so everyone is on the same page for Brown City Days.
