COUNCIL PROCEEDINGS FOR JULY 12, 2004

Meeting called to order at 7:00 P.M. by Mayor Carpenter.

Pledge of Allegiance led by CM JoAnn Potts.

PUBLIC QUESTIONS AND COMMENTS:

Larry Steigerwald questioned the City Council and how can CM Lukacs be Acting City Manager. And he questioned the motives behind the dismissal. He also stated that he didn't think the City Council gave Darcy Long a fair chance.

City Attorney Garno stated CM Lukacs is not a full time City Manager and that there is a State Law (MCL 15.182) that states that a City under 25 thousand

people, a person can hold 2 or more positions. (Corrected 7-26-04 to read "(MCL15.183) that states that in a City").

Charles Zuhlke asked the City Council to do the right thing and take a step back and look at what is best for Brown City. Also questioned about the illegal driveway at Ben's

Ken Brown stated that he saw M-Dot at Ben's.

Laura Carpenter stated that Ben's driveway problem has been turned over to M-Dot.

Art Potts stated that he believes in the City Council and what they are **doing is** right. (Corrected 7-26-04 to read "doing regarding the City Manager is right")

Larry Steigerwald also pointed out about the subdivision not being mowed, and other property along Maple Valley Road, coming into town that wasn't mowed. And about the junk semi-trailers at Explorers.

Move by CM Lukacs, second by CM Potts, to accept Darcy Long's resignation agreement.

ROLL CALL VOTE: Miller – Yes, Jacobson– Yes, Navock– Yes, Lukacs – Yes, Potts – Yes. 5 - Yes, 0 - No, 0 - Abstain, **0 - Absent**. Motion Carried. (**Corrected 7-26-04 to read "1-Absent"**)

Jennifer Decker questioned the legality of the Closed Session.

Darcy Long thanked the Community for allowing him to serve as City Manager and also the City Council.

- 6. Brown City Day's Committee The Brown City Day's Committee presented Dave VanCura with a plaque to thank him for all the work he does for Brown City Days.
- 7. Personnel (Lukacs) Interim City Manager Discussion. Two people are interested in the Interim City Manager job. One is Ken Brown and the other is CM Frank Lukacs.

CM Jacobson question if there is a conflict with appointing Frank Lukacs as Interim City Manager, and can he still vote as a Councilmember.

City Attorney Garno stated that under MCL 15.181 and MCL 15.1834C that this is legal. (Corrected 7-26-04 to read "under MCL 15.183(4)c that")

Move by CM Lukacs, second by CM Navock, to appoint Frank Lukacs as Interim City Manager.

ROLL CALL VOTE: Miller – No, Jacobson– No, Navock– Yes, Lukacs – Yes, Potts – Yes. 3 - Yes, 2 - No, 0 - Abstain, 0 - Absent. Motion failed because four votes are needed to pass. (Corrected 7-26-04 to read "1-Absent" and by adding "Pursuant to Section 2.13 of the City Charter".)

Move by CM Lukacs, second by CM Navock, to appoint Ken Brown as Interim City Manager.

ROLL CALL VOTE: Miller – Yes, Jacobson– Yes, Navock– No, Lukacs – No, Potts – Yes. 3 - Yes, 2 - No, 0 - Abstain, 0 - Absent. Motion failed because four votes are needed to pass. (Corrected 7-26-04 to read "1-Absent" and by adding "Pursuant to Section 2.13 of the City Charter".)

Move by CM Miller, second by CM Jacobson, to appoint Frank Lukacs as temporary City Manager until the July 26, 2004 Council Meeting.

Move by CM Lukacs, second by CM Navock, to appoint Frank Lukacs as Interim City Manager.

ROLL CALL VOTE: Miller – Yes, Jacobson– Yes, Navock– Yes, Lukacs – Yes, Potts – Yes. 5 - Yes, 0 - No, 0 - Abstain, 0 - Absent. Motion Carried. (Corected to read "1-Absent")

- a. Recommended the City run an Ad in the local papers for a full time City Manager.
- b. Appoint Christine Lee as City Councilmember at the next meeting to fill CM Jason Nielsen seat.
- c. Appoint Kelly Pavel as City Clerk at the next Council Meeting.

TREASURER'S REPORT

Treasurer Carol Walters gave her report. She stated that the City is working with the Post Office to get the Post Office Box numbers, because the mail is not being delivered without the PO Box numbers. Collected \$35,051.91 in taxes, and the City received \$1,931 from the state. Link Technologies received a tax bill when they weren't supposed to Treasurer Walters. Also the City will subtract \$2.50 per parcel for 776 parcels and write a check for the rest of the money to the State.

ATTORNEY'S REPORT:

- 1. Mapleview Estates: Received a check for \$12,750.00 from Mapleview Estates and now the case is closed.
- 2. Ordinance regarding water and sewer tap in fees for Non-City Residents. CM Jacobson introduced Section 5700 to amendment Chapter 5 Ordinance regarding water and sewer tap in fees for Non-City Residents for Public Hearing on 7/26/04 at 7:30 P.M.
 - **3.** Renaissance Zone: Keith Muxlow called City Attorney Garno on **how thes land purchase** is going. City Attorney Garno is working on getting the Title clearance and the USDA Loan. (**Corrected 7-26-04 to read "how the land purchase"**)

4. Lehn King Contract: (Corrected 7-26-04 by adding "Approved by City Attorney."

Move by CM Jacobson, second by CM Navock, to approve the contract with Lehn King CPA for three years. Motion Carried.

5. City Attorney Garno asked Jennifer Decker what was the problem with the way the City enter the Closed Session. Jennifer Decker was wondering about the legality of the Closed Session because of going from one room to another and **bring** in outsiders in. City Attorney Garno believes that the Closed Session was legal. (**Corrected 7-26-04 change "bring" to "bringing"**)

CITY MANAGER'S REPORT:

- 1. Freedom of Information Request: Prepared information on City Manager Long' personal file as requested by the Port Huron Times Herald. And delivered the file to City Attorney, Garno on Friday, July 2, 2004.
- 2. Renaissance Property:
 - a. Rescheduled the meeting for Tuesday, July 13th at 11:30 A.M.
 - b. IFT Application Meeting: Need to set a Public Hearing on July 26th Council Meeting.
- 3. Residence Concerns:
 - a. Found the letter from Davis Land Surveying dated 9/11/03 concerning Paul Czap's water problem.

Move by CM Miller, second by CM Jacobson, to proceed with Davis Land Surveying at a cost of \$1,600.00 to do a study of project. Motion Carried.

- b. Mr. Petters with the purchase of the property next door. He will attend the next meeting.
- c. Pond Construction within the City Limits: New Ordinance only addresses grade of pond, needs clarification on specific. Need to amend the Ordinance. Ken Brown Stated that ponds are under the DNR.
- d. Fourth Street Property House Construction Lots 6 & 7: Gave information concerning Ordinances to Mr. Willer and Mr. Turner.
- e. Weeds: Softwinds Subdivision is bankrupt will contact the bank about taking care of the cutting of the weeds/mosquito problem Also the school ball fields/ dusty roads overgrown. Weed/un-mowed lawn at 6905 Cade Road, need to find out the present owner.

County Commissioner Walters stated that the water bill is in William Madison's name.

- **f.** Mosquito Problem West Nile Disease: Mr. Halbert found a dead bird. (Corrected 7-26-04 by adding "It was suggested they be buried.")
- g. Accepted City Councilmember Jason Nielsen's resignation effective Thursday, July 8th, 2004 at 3:46 P.M.
- 4. Planning Commission: No quorum present. Need to contact members regarding their status on the committee. Total number of members was increased from 6 to 9.
- 5. Bullock Property: Court order corrections to be made on drainage problems by August 1, 2004. Met with DPW Supervisor Kinney, he stated that the field has been to wet due to the recent rains. The job should be done within three to four days from the start up time. Also DPW Supervisor Kinney found an error on the proposed map and is checking out the source.
- 6. Calls:
 - a. Mannick & Smith Associates about the Abandon Well Project. Need to call him back andsee what they want.
 - b. Webb's Insurance Company:
- 7. Main Street Sidewalk: DPW Dave Kinney estimates the cost of the South side, project will cost \$17,640.00, doesn't include curbs and gutters. Need to contact M-Dot first. Problem at the Post Office about people tripping on the sidewalk. Need to fix this.
- 8. LC United Painting: Received a bill for \$10,000.00 balance due on water tower. Need to check with the County Treasurer if all the payments were made...
- 9. Second Street Abandon House: Water in basement. Need to contact Judy Ferguson from the Public Health Director.
